ABSTRACT

Green Human Resource Management (GHRM) has emerged as a critical strategy for integrating environmental sustainability into organizational practices, business operations and decision-making processes. This study examined the role of GHRM in driving sustainable performance by examining practices such as green recruitment, green training, performance management and paperless office. The GHRM practices significantly enhance organizational sustainability by fostering pro-environmental behaviors, improving resource efficiency, and strengthening corporate reputation. Key enablers of successful GHRM implementation include leadership commitment, employee engagement, and alignment with corporate sustainability goals. Challenges such as resource constraints and resistance to change were identified. This paper offers practical recommendations for adopting GHRM practices and highlights its strategic importance in achieving long-term organizational and environmental objectives.

INTRODUCTION

In the face of global environmental challenges such as climate change, resource depletion, and pollution, organizations are increasingly being called upon to adopt sustainable practices. In response, Green Human Resource Management (GHRM) has emerged as a strategic approach that integrates environmentally sustainable practices into HRM functions, aligning organizational goals with environmental sustainability objectives (Dubey, Hafeez, and Yakovleva, 2024).

GHRM leverages traditional HR processes, such as recruitment, training, performance management, and employee engagement, to foster a culture of environmental awareness and accountability (Johnson, and Lee, 2024). For instance, green recruitment focuses on hiring individuals who align with the organization's sustainability values, while green training aims to equip employees with the skills needed to support eco-friendly initiatives. These practices not only

reduce the organization's ecological footprint but also contribute to its competitive advantage by enhancing reputation, reducing costs, and attracting sustainability-conscious talent.

The growing importance of GHRM is also reflected in its alignment with global frameworks such as the United Nations Sustainable Development Goals (SDGs). Specifically, GHRM contributes to goals related to climate action, sustainable consumption, and decent work. Despite its significance, however, the adoption and implementation of GHRM practices remain uneven across industries and regions, primarily due to challenges such as lack of awareness, resource constraints, and resistance to change (Ajonbadi, 2023).

Furthermore, while there is a growing body of research on environmental sustainability and its relevance to organizational practices, the strategic contribution of Green Human Resource Management (GHRM) to achieving sustainability goals remains underexplored. Existing studies largely focus on broader corporate sustainability initiatives without adequately addressing how HR practices can serve as a critical driver of environmental and organizational sustainability (Jabbour, and de Sousa Jabbour, 2016). Furthermore, although GHRM encompasses various practices such as green recruitment, training, and performance management, there is limited empirical evidence on how these specific practices translate into measurable sustainability outcomes, such as reduced carbon footprints, enhanced resource efficiency, and improved corporate reputation. This lack of clarity impedes organizations from effectively leveraging GHRM as a strategic tool for sustainability.

This study situates itself within the emerging discourse on GHRM, aiming to explore the components, drivers, and outcomes of GHRM. By examining the role of GHRM in promoting sustainability, this research seeks to provide actionable insights for HR professionals, organizational leaders, and policymakers striving to integrate environmental sustainability into their organizational frameworks.

Another gap lies in understanding the contextual factors influencing GHRM adoption. For example, industries and regions differ significantly in their approach to sustainability due to variations in regulatory environments, cultural attitudes, and resource availability (Ajonbadi, 2023). These contextual nuances are often overlooked in the existing literature, leading to a one-size-fits-all perspective that may not be applicable in diverse organizational settings.

This study addresses the gap by investigating the strategic contribution of GHRM to sustainability goals, with a particular focus on its components, implementation challenges, and measurable impacts. By doing so, it aims to bridge the theoretical and practical disconnect, providing actionable insights for organizations seeking to embed sustainability into their core HR practices.

LITERATURE REVIEW

Green Human Resource Management (GHRM) is a strategic approach that integrates environmental sustainability into human resource practices, aiming to align organizational goals with ecological priorities (HRMI, 2024). It reflects the broader organizational commitment to sustainability by embedding eco-friendly principles into every stage of the employee lifecycle, from recruitment to retirement. GHRM can be defined as the adoption of HR policies and practices

that promote the sustainable use of resources within organizations, with the goal of fostering environmental awareness and reducing the ecological footprint. Rani, and Mishra, (2014) defined a Green Organization and as a workplace that is environmental receptive, resource well organized and socially responsible, while they see Green HRM as the use of policies to support the sustainable use of resources within organizations and, more usually helped the reasons of environment sustainability. Dubey, et al. (2024) described GHRM as an integration of environmental management into traditional HRM functions, thereby creating a workforce that is motivated and equipped to engage in eco-friendly practices.

The following are dimensions of GHRM practices as discussed by Dubey et al (2024);

Green Recruitment and Selection: Green recruitment can be defined as the process of hiring individuals with knowledge, skills, approaches, and behaviors that identify with environmental management systems within an organization (Arulrajah, Opatha, and Nawaratne, 2015). Recruitment practices can support effective environmental management by making sure that new entrants are familiar with an organization's environmental culture and are capable of maintaining its environmental values. It also entails attracting and hiring candidates who share the organization's environmental values. Examples include job postings highlighting sustainability goals and incorporating environmental awareness into the hiring criteria. Attracting high-quality staff is a key HR challenge in the "war for talent" (HRMI, 2024). Firms are increasingly recognizing that building a reputation as a green employer is a powerful way to attract top talent. As environmental concerns become more prominent, organizations are incorporating green job descriptions into their recruitment strategies, emphasizing roles that align with sustainability goals. Green recruiting places the environment at the heart of hiring practices, positioning it as a core organizational value. This approach resonates deeply with prospective employees who are enthusiastic and often passionate about contributing to eco-friendly initiatives. Hiring individuals with a "green mindset" not only aligns with the company's sustainability goals but also simplifies onboarding. These recruits often have prior knowledge of sustainable practices, such as recycling, conservation, and promoting logical, eco-conscious behaviors. By embedding environmental values into the recruitment process, firms are building teams that are committed to creating a more sustainable future. Grolleau, Mzoughghi, and Pekuovic, (2012) in their study on impact of environmental standards of a company on recruitment of an employee found that environmental commitment of the company adds to profile of a company. In their primary survey, they found that professionals were more concerned with respect to the environmental strategy of a company (Shafique, Ansari, Farooq, and Shahzad, 2024).

Green Training and Development. equipping employees with the skills and knowledge needed to engage in sustainable practices. Training and development is a practice that focuses on development of employees' skills, knowledge, and attitudes, prevent deterioration of Environmental Management-related knowledge, skills, and attitudes. Training programs may cover waste management, energy conservation, and green innovation. Green training and development programs empower employees by fostering an understanding of the importance of environmental management (EM). These initiatives equip employees with practical skills for adopting energy-saving methods, minimizing waste, and promoting environmental awareness throughout the organization. Beyond technical training, these programs create opportunities for

employees to actively participate in solving environmental challenges, fostering a sense of ownership and contribution toward sustainability goals.

By integrating environmental values into the learning process, green training and development not only enhance employees' knowledge and skills but also nurture a culture of responsibility and innovation. Employees become more aware of the broader impact of their actions, helping the organization achieve its sustainability objectives while contributing to a greener future (Daily, and Huang, 2001). It helps them to embrace different methods of conservation including waste management within an organization. Furthermore, it sharpens the skill of an employee to deal with different environmental issues.

Green Performance Management. Performance management is the process by which employees are prompted to enhance their professional skills that help to achieve the organizational goals and objectives in a better way (Armstrong, and Taylor, 2020). Green performance management integrates environmental goals into employee performance evaluations, recognizing and rewarding eco-friendly contributions. As environmental management becomes a central component of global business strategy, performance management is evolving to align with this green shift, offering potential benefits for both organizations and employees. This approach focuses on addressing environmental concerns and aligning employee performance with the company's sustainability policies. It emphasizes accountability for environmental responsibilities, encouraging employees to adopt practices that support conservation, waste reduction, and energy efficiency. By embedding green principles into performance management, organizations create a culture where environmental stewardship becomes a shared responsibility, driving both individual and collective success. Many organizations today are addressing performance management by implementing corporate-wide environmental performance standards and utilizing green information systems and audits. A key challenge in environmental performance appraisal is ensuring that managers are held accountable not only for traditional performance objectives but also for their contributions to environmental management. Green Compensation and Benefits: This is offering rewards and incentives for sustainability-related achievements. These may include bonuses for reducing energy consumption or implementing environmentally friendly processes. Rewards and compensation are the major HRM processes through which employees are rewarded for their performance. These HR practices are the most powerful method which links together an individual's interest to that of the organizations. Incentives and rewards can influence employees' attention to the maximum at work

and motivate them to exert maximum effort on their part to achieve organizational goals. Though compensation and rewards increase green initiatives in organizations, it can never be completely free from some malpractices. Developing effective monetary incentives can be challenging due to the difficulty of accurately and fairly evaluating environmental behaviors and performance. By incorporating elements of green management in the compensation program, managers can promote the green behaviors among the employees. Further, managers can ask employees to bring specific green ideas pertaining to their individual jobs which can be through mutual decisions included into the objectives to attain in for the upcoming year, and attaining these objectives would be the basis of receiving incentives. Green rewards can include the use of workplace and lifestyle benefits, ranging from carbon credit offsets to free bicycles, to engage people in the green agenda while continuing to recognize their contribution.

Paperless office: Most of the work in the office is managed on paper but, with introduction of IT, the consumption of paper has been reduced. Dhamija, (2021) opined that today E-business and learning have changed the methods and procedures at offices converting them into paperless offices. Paperless office is a work place where the use of paper is either restricted or eliminated by converting important official documents and other papers into automated workflows. The practice greatly reduced the consumption of paper, the costs of paper-related actions including copying, printing, and storing, and also save the time used for searching paper documents (Jagadeesh, 2013). Reducing paper usage is a simple yet impactful way to conserve natural resources, minimize pollution, and save water and energy. Each sheet of paper we avoid using translates to fewer trees being cut down, less energy consumed in production, and a significant reduction in water usage. By adopting digital solutions and mindful practices, we can collectively reduce waste, protect the environment, and contribute to a more sustainable future.

THEORETICAL REVIEW

The theoretical foundation for understanding the role of Green Human Resource Management (GHRM) in promoting organizational sustainability is built on two prominent theories: the Resource-Based View (RBV) and Stakeholder Theory.

The Resource-Based View (RBV):

The Resource Based View of the firm, put forward by Barney (1991), posits that a firm's competitive advantage is derived from its unique resources and capabilities that are valuable, rare, inimitable, and non-substitutable (VRIN), Helfat, Teece, and Winter, E. M. (2023). Applying this perspective to sustainability, GHRM can be viewed as a critical organizational resource that contributes to long-term value creation through the following mechanisms:

Training and development programs under GHRM enhance employees' capacity to innovate and adopt green initiatives, creating a distinctive competitive advantage.
- ii. **Sustainability-Oriented Organizational Culture:** GHRM fosters a culture that prioritizes environmental stewardship, which becomes an intangible asset difficult for competitors to replicate. This culture aligns employees' behaviors with sustainability goals, ensuring consistency in green practices across the organization.

iii. **Operational Efficiency and Cost Savings:** Green HR practices reduce waste, optimize resource use, and enhance operational efficiency, directly contributing to organizational sustainability. The RBV highlights how GHRM serves as both a tangible and intangible resource, enabling organizations to achieve sustainable outcomes while differentiating themselves in the market.

Stakeholder Theory

Stakeholder Theory, developed by Freeman (1984), emphasizes the importance of addressing the needs and expectations of all stakeholders, including employees, customers, investors, communities, and regulatory bodies. This theory underscores the strategic relevance of GHRM in aligning organizational practices with stakeholder interests, particularly in the context of environmental sustainability (Donaldson and Preston 2023). **Internal Stakeholders (Employees):** GHRM initiatives, such as green training and employee involvement in sustainability projects, empower employees to act as advocates for environmental responsibility. Renwick, et al (2013) stated that engaging employees in green practices increases job satisfaction and strengthens their commitment to the organization's mission. **External Stakeholders (Community and Environment):** GHRM demonstrates the organization's commitment to environmental stewardship, enhancing its reputation among customers, communities, and governments. Green recruitment practices signal a focus on sustainability, attracting environmentally conscious candidates and investors. **Regulatory and Compliance Stakeholders:** Through green performance management and compliance-oriented HR policies, GHRM ensures adherence to environmental regulations, reducing legal and reputational risks. By integrating the principles of Stakeholder Theory, GHRM enables organizations to balance the interests of diverse stakeholders while advancing sustainability goals. It fosters trust, collaboration, and long-term relationships, which are essential for achieving environmental and social impact.

The combination of RBV and Stakeholder Theory offers a comprehensive framework for understanding the strategic value of GHRM. While RBV focuses on the internal capabilities and resources that make GHRM a source of competitive advantage, Stakeholder Theory highlights its role in meeting external expectations and enhancing stakeholder relationships. Together, these theories provide a robust foundation for analyzing the contribution of GHRM to organizational sustainability.
